SECRETARY'S REPORT

Tim Agner distributed minutes from August 27, 2022 board meeting. After discussion and corrections, the Minutes were approved. Mike Abraczinskas made the motion to approve, Amy Marshall seconded the motion, the minutes were approved by unanimous vote.

TREASURER'S REPORT

Rhonda Thompson distributed the treasurers report as information, did not include September banking information as it was not yet available.

FALL 2022 CONFERENCE PLANNING

- A. Program: Mike Abraczinskas walked through the agenda with all present. Computer assignments were confirmed, and last-minute details ironed out. Moderator folders were distributed by Connie to the session chairs.
- B. Hotel Amenities: Connie discussed locations of the meetings and meals. Wi-Fi will be available in meeting rooms and exhibit hall. Hotel is still recovering from Hurricane Ian, some of the damage is still visible. Hotel is experiencing a lot of turn over, this makes certain task difficult.
- C. Registrants, Exhibitors, and Sponsors: Ann reported a total of 258 preregistered, 24 speakers, 60 exhibitors, 41 booths (36 paid, 5 free). There were 240 registered attendees in 2021. The Wednesday morning has 22 prepaid attendees. The fall theme will be "Jungle Safari".

- D. Young Professionals: The Young Professionals hosted Tree Planting event on October 8 with Tree Charlotte. A total of 150 trees were planted. The event was not well attended.
